Friday Format: Pits (\$35) G.A (\$20) // 2-Day Pits (\$75) 2-Day G.A (\$45)

The field will draw pills for their position in the heat races. There will be "# " heat races. Each driver will participate in a 10 lap heat race. Points will be awarded to each participant based on their heat race finish and passing points. The top 44 highest cars in total passing points will earn a spot in one of two Friday A-Main's. [Odds in A-Main #1, Evens in A-Main #2]. There will be one B-Main lined up based on heat race passing points results (if needed). The B-Main will be 8 laps. The top four from B-Main will advance (Spots 23&24) in each A-Main. Friday's "MEGA Prelim" A-Main's will be 20 laps and pay the winner \$1,000 dollars. Additionally, the top five cars from each A-Main will be locked into Saturday's main event (Spots 1-10). The top three from each Friday feature will redraw (1-6) for Sat. starting spots. 4Th & 5th will start heads up on Saturday (Spots 7-10).

Saturday Format: Pits (\$50) G.A (\$35)

There will be four 'Qualifiers' lined up based on Friday feature results. Each 'Qualifier' will be 10 laps. The top three from each 'Qualifier' will advance (Spots 11-22) in the A-Main. There will be a 15 car 'Last Chance Showdown' with the top two advancing to the A-Main (Spots 23-24). There will be 1 MEGA qualifier provisional (Spot 25). (Spot 26) will be auctioned to highest bidder. Saturday's "MEGA" Finale A-Main will be 60 laps and pay the winner \$15,000!
